2. Adoption of agenda

11. Chair's announcements concerning Coordinators meeting

1) Requests for agendas and adoption of the January agenda

The Coordinators approved the two urgency requests on petition 1332/2016 and 1247/2016 and put them to the January agenda.

Also petitions 1215/2015 and 1216/2015 on the train accident in Santiago de Compostela as well as petition 0480/2016 on cleft lip and palate were placed on the January agenda.

They agreed to have the Taranto petitions on the agenda just before the fact-finding visit, which is foreseen for the second half of 2017 (*possibly, in July*).

Petition 2334/2014 would be put to the agenda as soon as the ECON reply has been received.

Petitions 2622/2014 and 0337/2015 may be put to the agenda after their respective court cases are closed.

Petitions 1412/2015 and 0820/2015 were agreed to be put to the February agenda.

After these changes, the January agenda was adopted.

2) Reports and opinions

3) Contested recommendations

Chair's compromise was approved for all other contested recommendations but for petition 0626/2016, where it was agreed to keep the petition open, ask the Commission for information and send to LIBE for information.

A small clerical error concerning the recommendation on petition 0657/2016 was corrected.

4) Requests concerning B-items

From the agenda of 9/10 November, items 29 (petition 2635/2013), 32 (petition 1940/2014), 35 (petition 441/2015), 50 (petition 1287/2015), 51 (petition 1297/2015), 58 (petition 1380/2015) were closed without further action. Item 41 (petition 828/2015) was closed, with a letter to the Belgian authorities.

Items 27 (petition 302/2013) and 48 (petition 1236/2015) will be kept open and scheduled for an upcoming committee meeting. Items 33 (petition 2124/2014) and 57 (petition 1363/2015) will be kept open and the Commission will be asked for further information. Item 60 (1394/2015) will be kept open and scheduled for a committee meeting and Finnish authorities will be requested

information.

5) Preparations for Brexit

The Coordinators were invited to send their comments concerning the analysis on the impacts of Brexit by 8 December.

At this point, no policy choices need to be indicated; this is just a factual analysis.

6. Research programme 2017

The Coordinators agreed on the PETI research programme. All proposals can be taken on board either as part of the existing proposals or as new requests. The Policy Department C will finalise the document.
